MOVEMENT OF PERSONS & VEHICLES WITHIN THE STATE

Permitted within State subject to strict adherence to the provisions of the SOP for Movement of Persons and Vehicles in the State available at:

Intra and inter district movement of private and passenger vehicles of every category is permitted across Nagaland subject to 50% of total occupancy.

Passengers, drivers, attendants to wear mask at all times.

Passenger vehicles to maintain a daily log book of all travelers with the following details: Name, Phone, and date of travel.

All passengers must sanitize their hands before boarding.

Vehicles must be washed daily and disinfected periodically.

Drivers/attendants not to assemble or gather in groups at bus/taxi/auto rickshaw stands.

Physical distancing of 6 feet.

Number of customers inside shop to be kept at minimum.

Spitting strictly prohibited.

Sanitisers to be made available for staff & visitors.

Regular disinfection of frequently touched surfaces.

Masks, gloves, sanitisers to be made available for staff & guests.

Regular disinfection of frequently touched surfaces.

6 feet distancing of all staff and guests at all times.

BARBERSHOPS/SALONS

Permitted to open and function subject to the provisions of the SOP for Barbershops and Salons available at:

VIOLATION OF SOP WILL ATTRACT ACTION AS PER LEGAL PROVISIONS AGAINST MANAGEMENT/GUEST.

Skin related services not allowed.

Prior appointments only.

No mask, no entry.

Only asymptomatic staff and clients to be allowed.

Staff must wear protective gears (face shield, triple layer mask etc).

All equipment and seats to be sanitised after each client/use.

Daily log book of all clients with name & verified phone number.

Regular disinfection of frequently touched surfaces.

RELIGIOUS PLACES

Religious places/place of worship permitted to open outside the containment zones subject to strict adherence to all the provisions of the SOP for Religious Places and Places of Worship available at:

VIOLATION OF SOP WILL ATTRACT ACTION AS PER LEGAL PROVISIONS AGAINST MANAGEMENT/VISITOR.

No mask, no entry. Masks to be worn at all times.

Only asymptomatic visitors to be allowed.

Physical distancing of 6 feet.

Maximum of 30% of the capacity or 100 persons (whichever is lower).

Large gatherings/congregation prohibited. Staggering of visitors may be done.

In view of potential threat of spread of infection, as far as feasible recorded devotional music/songs may be played and choir or singing groups should not be allowed.

Frequent cleaning and disinfection by the management.
