ORDER

(UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE, 1973)

Whereas, based on the declaration by the Government of the outbreak of COVID-19 as a pandemic and the subsequent promulgation of the Epidemic Diseases Act, 1897 by the State Government vide Notification dated 18th March, 2020 and Order dated 22nd March, 2020, it is apprehended that there is likelihood of a fast and wide spread community transmission of COVID-19 in the district. Therefore, it has become necessary to take all required precautionary steps to mitigate the possible serious effects of the spread of COVID-19 for public health, public safety and public order

Therefore, I, **Shri Rothihu Tetseo, IPS**, District Magistrate & Commissioner of Police, Dimapur in exercise of the Power conferred upon me by Section 144 of the Criminal Procedure Code, 1973 do hereby promulgates the following prohibitory orders for maintaining public health, public safety and public order in Dimapur district till further order.


1. Assembly or gathering of more than 05 (Five) persons is prohibited. (However, certain pre-arranged gatherings will be subjected to special permission from CP Office).
2. All vehicular movement of non-essential nature is prohibited.

The order will however be exempted in respect of Police/ Army/ Para-Military forces/ Magistrate on duty/ Doctors and Medical Staff and persons engaged in emergency services.

This order is passed exparte U/S 144 (2) Cr.PC. This order will come into force **with effect from 0600 Hrs of 24.03.2020** and shall remain in force till further orders.

For the violation of the aforesaid order, if any is found guilty, he/she will be liable for punishment under Section 188 of the Indian Penal Code.
