Sub: Proposal for identification of Private hospitals for emergency cases and In door patients.

Sir,

As per the order no.H&FW-27/b-30/nCoV2020(Pt)/969-77, dated Kohima, the 31st March 2020, IMDH is converted to Covid-19 hospital and non Covid patients seeking emergency healthcare are diverted to Lenjem Hospital, Mokokchung. However this hospital has a capacity of 30 beds only and with the opening of the lockdown and the approaching monsoon season, more patients are expected for hospitalisation. Therefore a proposal is hereby submitted to the higher authority so as to divert the patients from IMDH to the following private hospitals for emergency care and hospitalisation.

1. Woodland Nursing Home, Mokokchung : 35 bedded, empanelled under AB- PMJAY.
2. Impur Christian Hospital, Impur : 20 bedded, empanelled under AB- PMJAY.
